- b. SC/ST candidates of other States (not recognized by the Government of Tripura) should apply for unreserved vacancy as UR candidate along with recruitment fee prescribed for UR candidates/s.

- 2. TSECL will not be responsible for any kind of postal delay.
- 3. Only short listed candidates will be called for interview.
- TA/DA for attending the interview will be paid by the Corporation on presentation of original documents subject to maximum limit of Rs.8, 000/- (Rupees eight thousand only).
- 5. Selection will be based on interview only.
- 6. Selection committee reserves the right to relax any of the terms for selection & appointment.
