## MEMORADUM

In pursuance to the Finance Department, Government of Tripura notification vide Memorandum No.F.5(1)-FIN(PC)/2021/2247-2447 dated, 12-03-2024 and subsequent approval by the Board of Directors of the TSECL in its 114<sup>th</sup> Meeting held on 28<sup>th</sup> day of May' 2024, it is hereby decided & ordered that all employees of the Tripura State Electricity Corporation Limited (TSECL) as well as deputed employees of regular pay scale will get further installment of Dearness Allowance (DA) @ 5% over the Basic Pay (Revised Pay Rules'2018) i.e total quantum of DA shall stand at 25% (20% + 5%) over the Basic Pay with effect from 01-01-2024.

Further in the said Board Meeting, it is directed that the arrears of aforesaid DA w.e.f 01-01-2024 will be paid in two parts i.e. arrear DA of January, February and March' 2024 will be paid with the monthly salary of June, 2024 and rest of two months (April & May) arrears will be paid with the monthly Salary of July, 2024.
