The undersigned is directed to inform that the rate of "Festival Grant" for various categories of employees/ staff/ workers shall be as shown in the below table:

4.	PTWs/Contractual Workers/Casual Workers etc. who are engaged with prior concurrence of Finance Department (The copy of concurrence to be enclosed with the bill).	Rs. 2,200/-
1	Pensioners / Family Pensioners	Rs. 2,000/-
1	Anganwadi Workers / Helpers	Rs. 2,200/-
	Home Guards / SPOs	Rs. 2,200/-
8.	Priests of Government run Temples	Rs. 2,000/-

2. Regarding Workers / Staff under Central Scheme, the concerned Department may decide.

3. An employee can avail the grant only once in any financial year and only in a single installment and for a single festival only.

4. A declaration from concerned employee has to be taken stating that he/she has not availed Festival Grant for more than one occasion in any Financial Year.

5. An employee can take festival grant on the occasion of any one of the

following festivals:

- i. Durga Puja
- ii. Christmas
- iii. Garia Puja
- iv. Buddha Purnima
- v. Eid-Uz-Zuha

vi. Bengali New Year

- vii. Eid UI- Fitre
- viii. Guru Nanak's Birthday
- ix. Mahavir Jayanti

6. The order shall come into force with immediate effect and remain in force until further order.

7. Regarding Festival Advance, the rate and terms & conditions as laid in the Memo issued vide No.F.10(51)-FIN(Exp-II)/63(L)/158-307, Dated 21st September, 2023 will remain unchanged. In addition, a declaration has to be taken from the concerned employee stating that he / she has not availed Festival Advance more than one occasion in a financial year and entire amount of advance has been paid back to the exchequer, which shall be countersigned by the DDO of the office, in which the concerned employee is presently posted.
