
MEMORANDUM

Sub-"Ease of doing Business in Tripura" at TSECL/Instructions regarding documents required for obtaining new service connection in case of Industry/Firm/Company.

Govt Of India has taken various initiative for "**Ease of doing business in India**" Department of Industrial Policy and Promotion, Govt Of India has made recommendations to the states in respect various areas and has recommended to streamline obtaining of large number of documents required to obtain electricity connection to reduce it to two numbers for Industry/Firm/Company. The TSECL has accordingly reviewed the various instructions contained in the Supply code Regulation 2004 and has decided to simplify and minimize the documents required for release of electricity connection for **Industry/Firm/Company** as follows

- I. Only **2 documents** are required from the applicant for obtaining electricity connection.
 - a. Ownership document.(any of the following)
 - i) Occupancy of premises, an applicant who is not an owner of premises shall, furnish no objection certificate from owner of premises. ii) copy of sale deed or lease deed iii) Valid industrial license.
 - b. MoA/Partnership Deed.(any of the following)
 - i) Partnership deed and an authorization in the name of the applicant for signing the requisition form and agreement.
 - ii) Memorandum of Article s of Association.

All concerned are requested to adhere to the above instructions scrupulously. The above condition is applicable in case of Industry / Firm/ Company only.
