NOTIFICATION

Subject: Safety provisions for internal/external electrical installations.

In exercise of the powers conferred under Section 162(1) of the Electricity Act- 2003 and in view of the recommendations at Sl. No. 178 and 179 of the Business Reform Action Plan (**BRAP-2024**) on different Regulations of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations' 2023, the Governor of Tripura is pleased to notify the instructions to be followed by Industry/Firm/Company with respect to internal/external electrical installations:

1. Internal/ External electricity installations typically shall be carried out by the licensed professional / company / contractor or a person licensed in this behalf by the State Government and on its behalf under the direct supervision of a person holding a certificate of competency and by a person holding a permit issued or recognized by the State Government as per Regulation No.31 and 32 of CEA (Measures relating to Safety and Electric Supply) Regulations' 2023.
2. Inspection of internal/ external electricity installations is to be carried out at least once in every 5 years by Contractor / Company/ Owner/ Supplier/Electrical Inspector or a person having a Certificate of competency in the relevant field as per Regulation No. 32 of CEA (Measures relating to Safety and Electric Supply) Regulations' 2023.
3. Certificate of compliance by Contractor/ Company/ Owner/ Supplier has to be issued and submitted to the Electrical Inspector as per prescribed format of Tripura Electricity Regulatory Commission (TERC) or Schedule-II of CEA Regulations- 2023.
4. Quality check of internal/ external electricity installation works shall be carried out by the Contractor / Company /Owner/ Supplier or any Person having Supervisory License obtained from Electrical Inspectorate in the relevant field.
5. Quality check or final inspection shall be done by a third-party having requisite qualification to ensure the quality and safety of internal/ external electricity installations.

This shall come into effect from the date of publication in the Official Gazette.
