#### CHAIRMAN AND MEMBER

#### TRIPURA ELECTRICITY REGULATORY COMMISSION

**Qualifications:** The Chairman and Member shall be the persons of ability, integrity, standing who have adequate knowledge of and has shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management or the requisite qualification to have been appointed as Judge of the High Court or a District Judge. In case Chairman does not possess qualification to be appointed as Judge of the High Court or a District Judge, the Member must have this qualification.

**Previous employment:** The person appointed would have to resign from the service to which he/she belongs even if on the date of his/her appointment he/she has not attained the age of superannuation. Further, in respect of persons in service, copies of their Annual Confidential Reports (ACR) Dossiers covering a period of last 5(five) years may be enclosed.

**Pay & allowances:** The Chairman and Member of the Commission shall be appointed in the following Scale of Pay with other allowances as are admissible to corresponding Grade Officers of State Government:-

(i) **Other then retired person:**

Level-21 of Tripura State Pay Matrix,2018 (ROP,2017) (Apex Scale (Rs.52,000 - 77,000/-) + GP NIL pre-revised) for Chairman.

Level-20 of Tripura State Pay Matrix,2018 (ROP,2017) (HAG + Scale (Rs.37,400 - 67,000/-) + GP Rs.8700/- pre revised) for Member.

(ii) **For Retired Person:**

Remuneration will be fixed as per extant rules of Finance Department for fixing remuneration for retired Government employees.

**Age:** The Chairman and Member shall hold office for a term of five years from the date he enters upon his office, or till he attains the age of sixty five years, whichever is earlier.

**Housing:** The Chairman and Member of the Commission shall be provided with accommodation of the status admissible to the officers of Level-21 of Tripura State Pay Matrix,2017.

**Transport:** The Chairman and Member of the Commission shall be provided with staff cars with drivers.

**Travelling Allowance:** For journeys performed on duty or at the time of interview/appointment/retirement, the Chairman and Member of the Commission shall be entitled to draw such travelling allowances as admissible to the officers of Level-21 of Tripura State Pay Matrix,2018.


**Medical:** Medical treatment for the Chairman/ Member and his dependent family members, during the tenure of his appointment, shall be provided in accordance with the rules applicable to the officers of Level-21 of Tripura State Pay Matrix,2018.

**Other facilities:** House attended, Newspaper, Telephone and one time LTC shall be provided for Chairman and Member of the Commission.

**N.B.:-** If Chairman is from Law back ground, appointment of 2<sup>nd</sup> Member will not be necessary.

**How to apply:** The application, on plain paper duly signed by the candidate with supporting documents should be sent to the Secretary, Department of Power, Government of Tripura, New Secretariat Complex, Capital Complex, Agartala,Pin-799010.Last date for receipt of application is **19-09-2024**.

The short listed candidates will be called for interview before the Selection Committee constituted by the Government u/s 85 of the Electricity Act, 2003.
