1. The bidder must submit Photo copy of PAN Card, **Photo copy of GST** registration certificate.
2. Period of completion: - **14 (fourteen) days.**
3. The rate should be quoted in both in words and figures. In case of any discrepancy the amount mentioned in word will be considered.
4. The bidder must quote their rates as per Basic price and GST separately and any other charges if applicable.
5. The rate quoted shall be firm.
6. Consignee: - Sr. Manager (Elect.), Gas Thermal Electrical Sub-Division, Rokhia, Sepahijala, Tripura.
7. The offer shall remain valid for 3(three) months from the date of opening.
8. Payment will be made by the Deputy General Manager, GTED, Rokhia after successful completion of the work. No advance payment will be made in any circumstances.
9. The quotation shall be submitted in sealed envelope properly super scribing NIQNo, Name of work and due date/time of dropping.
10. Taxes & Duties as applicable shall be deducted at source as per norms.
11. In case of any dispute, the decision of the Tripura Power Generation Ltd. Authority shall be final and binding.

**12. ARBITRATION**

- I. All disputes or differences in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.
- II. The arbitration shall be conducted by an arbitrator, to be nominated by TPGL and he will be the sole arbitrator to conduct the arbitration.
- III. The arbitration shall be conducted in accordance with the provisions of Arbitration & Reconciliation Act, 1996 or any statutory modification thereof. The venue of arbitration shall be at Agartala.
- IV. The arbitrators may, from time to time with the consent of all the parties enlarge the time for making the award.
- V. The arbitrator shall have full powers to review and /or revise any, decision, opinion, direction, certification or valuation of the engineer in accordance with the Contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the engineer for the purpose of obtaining the said decision.
- VI. During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the contract.
