TERMS & CONDITONS

1. The bidder must submit Photo copy of PAN Card&Photo copy of GST registration certificate.
2. Period of completion: - 1(one) Year from the date of issue of LOA.
3. The rate should be quoted in both in words and figures. In case of any discrepancy the amount mentioned in word will be considered.
4. The bidder must quote their rates as per Basic price and GST separately and any other charges if applicable.
5. The rate quoted shall be firm.
6. Executing officer: - Sr. Manager, Gas Thermal Mechanical Sub-Division No. II, Rokhia, Sepahijala.
7. The bidder must have experience in similar nature of work.
8. Payment will be made by the Deputy General Manager, GTED, Rokhia after successful completion of the work. No advance payment will be made in any circumstances.
9. The quotation shall be submitted in sealed envelope properly super scribing NIQNo, Name of work and due date/time of dropping.
10. Taxes & Duties as applicable shall be deducted at source as per norms.
11. In case of any dispute, the decision of the Tripura Power Generation Ltd. authority shall be final and binding.
12. The bidder shall submit the following documents in sealed envelope along with the offer.
 - A. Photo copy of Tax clearance certificate/ PTC of current validity / PAN Card.
 - B. Copies of performance certificate issued by any govt./PSU organization.
 - C. Copy of Trade License.
 - D. Copy of Labour registration.
13. The bidder shall have to submit the amount of Earnest money as stipulated in the shape of demand draft from any Nationalised Bank in favour of Deputy General Manager, Gas Thermal Electrical Division, Rokhia, Payable at SBI, Bishalgarh, along with the bid.
14. The offer shall remain valid for 03(three)months from the date of opening.
15. All spares shall be supplied by the agency as and when required including Gas charging.
16. The agency is to perform servicing of each Air Conditioner at least in the interval of 01(one) month during the Contract Period. The agency shall have to attend with in 24hours for servicing as and when called by the Officer in charge. Otherwise, a penalty of 250.0(Rupees two hundred fifty) only per call will be deducted against each call from the bill.
17. The Work Order may be cancelled at any time with a notice of 15 days against unsatisfactory performance.
18. The successful bidder shall have to sign a formal agreement and be required to furnish a contract performance guarantee @10% of the total contract price in the shape of demand draft in favour of Deputy General Manager, Gas Thermal Electrical Division, Rokhia, Payable at SBI, Bishalgarh, with in 07(seven) days from the date of issue of LOA.
19. The earnest money may be forfeited if the bidder fails to submit the contract performance Guarantee and to sign the formal agreement.
20. The contract performance guarantee shall be forfeited if the bidder fails to execute the work successfully in scheduled period of completion.
21. The bid shall be submitted in 2 (two)parts in separate sealed envelopes properly super scribing NIQ No. name of work& bid opening date containing in 01(one) sealed cover as follows.

21.1 Part-I: Pre-Qualification Bid

- A. Containing Bid earnest money as per the stipulated of the Bid Documents in a separate sealed envelope and cost of Tender Documents separately, if downloaded, in the shape of demand Draft from any Nationalised Bank, in favour of Deputy General Manager, Gas Thermal Electrical Division, Rokhia payable at State Bank of India, Bishalgarh Branch. The Bid will be rejected without cost of Tender Documents, if Downloaded.
- B. Containing Documentary evidence of the Bidder fulfilling the Qualifying Requirements stipulated in the NIQ.
- C. The document to be submitted shall include copies of the relevant work order/Award letter / Agreements etc. and corresponding completion certificates issued by concern clients. The bidder shall also submitted professional tax clearance certificate and all such other documents deemed necessary in support of their meeting the stipulated qualifying requirements and its credentials without which the quotation will be rejected.

21.2 Part-II: Price Bid

- A. The price bid should be quoted both in words and figures in the scheduled of work of the bidding document. Taxes as applicable shall be deducted at source as per norms.
- 22. The quoted rate would be fixed during the period of contract.
- 23. In case of any dispute, the decision of the Tripura Power Generation Limited Authority shall be final and binding.

24. ARBITRATION

- A. All disputes or differences in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.
- B. The arbitration shall be conducted by an arbitrator, to be nominated by TPGL and he will be the sole arbitrator to conduct the arbitration.
- C. The arbitration shall be conducted in accordance with the provisions of Arbitration & Reconciliation Act, 1996 or any statutory modification thereof. The venue of arbitration shall be at Agartala.
- D. The arbitrators may, from time to time with the consent of all the parties enlarge the time for making the award.
- E. The arbitrator shall have full powers to review and /or revise any, decision, opinion, direction, certification or valuation of the engineer in accordance with the Contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the engineer for the purpose of obtaining the said decision.
- F. During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the contract.
- 25. The bidding documents are not transferable and cost of bidding documents is not refundable under any circumstances.
- 26. Any bid received after the time and date fixed for submission of bid shall be rejected. Bid received through post/courier after the fixed date and time will not be entertained.
- 27. The Tender Form shall be signed by the tenderer /bidder on all pages. All corrections to rates and items in the bid should be initialed by the bidder.
- 28. The agency shall have to submit an INDEMNITY BOND as per TPGL format on a Non judicial Stamp Paper value of Rs. 30.00 only.
