01. The bidder must have experience in similar nature of work. The document to be submitted shall include copies of the relevant work order/ Award letters, Agreement etc. and corresponding completion certificates issued by the concerned clients.
02. The bidder shall submit all such documents deemed necessary in support of their meeting the stipulated qualifying requirements and its credentials without which the quotation will be rejected.
03. Period of completion: - 08 (eight) days from the date of issue of Work Order.
04. Consignee: - The Sr. Manager (Elect.), GTESD, Rokhia, Sepahijala, Tripura.
05. The Offer shall remain valid for 3 (three) months from the date of opening.
06. The payment will be processed on submission of Tax invoice/bill in Triplicate after successful completion of the work duly certified by the officer in charge. No advance payment will be made in any circumstances.
07. Taxes & Duties as applicable shall be deducted at source as per norms.
08. The quotation will be received at the **O/o the Addl. General Manager, Generation Circle, Bidyut Bhavan, Agartala & O/o the Deputy General Manager, Gas Thermal Electrical Division, Rokhia upto 5:00 PM on 17/03/2025** fixed for receiving. The bid quotations shall be opened on **18/03/2025 at 1:00 PM**, if possible, in presence of the intending bidder at O/o the Deputy General Manager, Gas Thermal Electrical Division, Rokhia. If the date fixed for opening will be declared holiday or remain closed, the quotation will be opened on the next working day with same terms and condition.
09. Any quotation received after time and date fixed for submission of bid shall be rejected. Bid received through post/courier after the fixed date and time will not be entertained.
10. The Bid shall be submitted in 2 (Two) parts in separate sealed envelopes properly super scribing NIQ No., name of work, and bid opening date containing in 1 (one) sealed cover as follows:

11. The rate & amount should be quoted both in words and figures in the schedule of work of the Bidding Document.
12. The bidder must quote their rates and all taxes and duties and other charges clearly, if any.
13. The rate quoted shall be firm.
14. The quoted rate would be fixed during the period of contract.
15. In case of any dispute, the decision of the TPGL Authority shall be final.
16. TPGL may cancel the contract/NIQ at any time without assigning any reason thereof.
17. TPGL reserves the right to accept or reject any bid or annul the bidding process and reject all such bids at any time prior to award of contract, without thereby incurring any liability to the affected applicant(s) or any obligation to inform the affected applicant(s) of the ground for such decision.

18. ARBITRATION

- I. All disputes or differences in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.
- II. The arbitration shall be conducted by an arbitrator, to be nominated by TPGL and he will be the sole arbitrator to conduct the arbitration.

 - V. The arbitrator shall have full powers to review and /or revise any, decision, opinion, direction, certification or valuation of the engineer in accordance with the Contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the engineer for the purpose of obtaining the said decision.
 - VI. During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the contract.
