1. The bidder must have experience in similar nature of work. The document to be submitted shall include copies of the relevant work order/ Award letters, Agreement etc. and corresponding completion certificates issued by the concerned clients.
2. The bidder shall submit all such documents deemed necessary in support of their meeting the stipulated qualifying requirements and its credentials without which the quotation will be rejected.
3. Scope of Work: Refilling of CO<sub>2</sub> fire extinguishers of different capacities including:
  - a. New bend pipe, hose with horn, and valve supply
  - b. Hydrotesting of all cylinders
  - c. Packing, transportation (to & from Rokhia), loading/unloading
4. Period of completion: - 4 (four) weeks from the date of issue of formal purchase order.
5. Extension of Time: If the delivery of materials is delayed due to reason beyond the control of supplier, the supplier shall without delay give notice to the purchaser in writing for an extension of time with detail justification. The purchaser on receipt of such notice may agree to extend the contract delivery date if reasonable but without prejudice to other terms and conditions of this contract.
6. Executing officer: - Sr. Manager, Gas Thermal Mechanical Sub-Division No. I, Rokhia, Sepahijala, Tripura.
7. The rate should be quoted in both in words and figures. In case of any discrepancy the amount mentioned in word will be considered.
8. The bidder must quote their rates as per Basic price and GST separately and any other charges if applicable.
9. The rate quoted shall be firm.
10. Payment will be made by the Deputy General Manager, GTED, Rokhia after successful completion of the work. No advance payment will be made in any circumstances.
11. The quotation shall be submitted in sealed envelope properly super scribing NIQ No, Name of work and due date/time of dropping.
12. Taxes & Duties as applicable shall be deducted at source as per norms.
13. In case of any dispute, the decision of the Tripura Power Generation Ltd. authority shall be final and binding.
14. The bidder shall submit the following documents in sealed envelope along with the offer.
  - A. Photo copy of PAN Card.
  - B. Photo copy of GST registration certificate.
  - C. Copy of Trade License/ Enlistment.
  - D. Photo copy of Tax clearance certificate/ PTC of current validity.
  - E. Copies of the relevant work order/ Award letters, Agreement etc. and corresponding completion certificates issued by the concerned clients.
15. The bidder shall have to submit the amount of Earnest money as stipulated in the shape of demand draft from any Nationalised Bank in favour of Deputy General Manager, Gas Thermal Electrical Division, Rokhia, Payable at SBI, Bishalgarh, along with the bid.
16. **Tender without Tender Fee & EMD shall not be accepted.**
17. The offer shall remain valid for 03 (three) months from the date of opening.
18. The Purchase Order may be cancelled at any time with a notice of 15 days against unsatisfactory performance.
19. The contract performance guarantee shall be forfeited if the bidder fails to execute the work successfully in scheduled period of completion.
20. The bid shall be submitted in 2 (two) parts in separate sealed envelopes properly super scribing NIQ No. name of work & bid opening date containing in 01(one) sealed cover as follows.
- 21.1 **Part-I: Pre-Qualification Bid**
  - A. Containing Bid earnest money as per the stipulated of the Bid Documents in a separate sealed envelope and cost of Tender Documents separately, if downloaded, in the shape of demand Draft from any Nationalised Bank, in favour of Deputy General Manager, Gas Thermal Electrical Division, Rokhia payable at State Bank of India, Bishalgarh Branch. The Bid will be rejected without cost of Tender Documents, if Downloaded.

- B. Containing Documentary evidence of the Bidder fulfilling the Qualifying Requirements stipulated in the NIQ.
- C. The document to be submitted shall include copies of the relevant work order/Award letter / Agreements etc. and corresponding completion certificates issued by concern clients. The bidder shall also submitted professional tax clearance certificate and all such other documents deemed necessary in support of their meeting the stipulated qualifying requirements and its credentials without which the quotation will be rejected.

**21.2 Part-II: Price Bid**

- A. The price bid should be quoted both in words and figures in the scheduled of work of the bidding document. Taxes as applicable shall be deducted at source as per norms.
- 21. The quoted rate would be fixed during the period of contract.
- 22. In case of any dispute, the decision of the Tripura Power Generation Limited Authority shall be final and binding.

**23. ARBITRATION**

- A. All disputes or differences in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.
- B. The arbitration shall be conducted by an arbitrator, to be nominated by TPGL and he will be the sole arbitrator to conduct the arbitration.
- C. The arbitration shall be conducted in accordance with the provisions of Arbitration & Reconciliation Act, 1996 or any statutory modification thereof. The venue of arbitration shall be at Agartala.
- D. The arbitrators may, from time to time with the consent of all the parties enlarge the time for making the award.
- E. The arbitrator shall have full powers to review and /or revise any, decision, opinion, direction, certification or valuation of the engineer in accordance with the Contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the engineer for the purpose of obtaining the said decision.
- F. During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the contract.
- 24. The bidding documents are not transferable and cost of bidding documents is not refundable under any circumstances.
- 25. Any bid received after the time and date fixed for submission of bid shall be rejected. Bid received through post/courier after the fixed date and time will not be entertained.
- 26. The Tender Form shall be signed by the tenderer /bidder on all pages. All corrections to rates and items in the bid should be initialed by the bidder.
