

TERMS & CONDITONS

1. The bidder must be IRDAI approved Insurance Company having license to operate business in the state of Tripura with an establishment at Agartala.
2. The bidder must have experience of providing insurances coverage for power generating station equipment/Industrial establishment insurance during last 03 (three) years from the date of issue of this bid and must submit proved of Experience. The Bidder must submit copy of **GST Registration Certificate, Trade License, PAN Card** issued by the competent Authority. The Bidder must submit yearly Turnover of business for last 3(three) financial years along with year wise amount of claim settled.
3. The quotation shall be submitted in 2 (Two) parts in separate sealed envelopes properly supers cribbing quotation no, Name of Work, and bid opening date.

PART-I **Pre-qualification Bid**

 9. No over writing in BOQ will be considered and if any discrepancy arises then the amount written in words will be considered as final.
 10. Any bid received after the time and date fixed for submission of quotation shall be rejected. Quotation received through post/courier after the fixed date and time will not be entertained.
 11. In case of any dispute, the decision of the Tripura Power Generation Ltd. Authority shall be final and binding.

- II) The sum insured will be as per asset details attached with SNIQ.
III) The insurances policy and claim settlement shall be guided by IRDAI regulation.
IV) Claims (if any) under the insurances policy shall be settled within 45 (forty five) days from the date of 1st information.

15. ARBITRATION

15.1 All disputes or differences in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.

15.2 The arbitration shall be conducted by an arbitrator, to be nominated by TPGL and he will be the sole arbitrator to conduct the arbitration.

15.3 The arbitration shall be conducted in accordance with the provisions of Arbitration & Reconciliation Act, 1996 or any statutory modification thereof. The venue of arbitration shall be at Agartala.

15.4. The arbitrators may, from time to time with the consent of all the parties enlarge the time for making the award.

15.5 The arbitrator shall have full powers to review and/ or revise any, decision, opinion, direction, certification or valuation of the engineer in accordance with the Contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the engineer for the purpose of obtaining the said decision.

15.6. During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the contract.
