Terms & Conditions

01. The bidders must have experience in similar nature of work.

02. Period of completion:- 12 (Twelve) months from the date of commencement.

03. The rate should be quoted both in words and figures.

04. The bidders must quote their rates and all taxes and duties and other charges clearly, if any.

05. The rate quoted shall be firm.

06. Consignee :- The Sr. Manager, Gas Thermal Mechanical Sub-Division, Baramura, Khowai Tripura.

07. The bidder shall submit a declaration stating that the bidder has non been blacklisted or performed any mal practice or fraudulent practice in any work under Govt. / PSU or any agency and this declaration shall be duly signed before notary public.

08 INSURANCE:

- O8.1 The Bidder shall also take insurance for Third Party Liability covering loss of human life, engineers and workmen and also covering the risks of damage to the third party/material/equipment/properties during execution of the Contract. Before commencement of the work, the Bidder will ensure that all its employees and representatives are covered by suitable insurance against any damage, loss, injury or death arising out of the execution of the work or in carrying out the Contract. Liquidation, Death, Bankruptcy etc., shall be the responsibility of bidder, where no expense will be borne by TSECL.
- 08.2 In case of any loss or damage or pilferage or theft or fire accident or combination of the said incidents etc. under the coverage of insurance, the Contractor shall lodge the claim as per rules of insurance. Any FIR required to be lodged to local Police Station shall be the responsibility of the bidder.
- 08.3 The bidder shall arrange to supply water even if the claim is unsettled for timely completion of the work. The final financial settlement with the insurance company shall be rested upon the Contractor.
- 9. TERMINATION FOR INSOLVENCY: TPGL may at any time terminate the contract by giving written notice to the contractor/bidder without compensation to the contractor/ bidder, if it becomes bankrupt or otherwise insolvent, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the TPGL.
- 10. TERMINATION FOR CONVENIENCE: TPGL, may by written notice sent to the contractor/ bidder, to terminate the contract, in whole or in part at any time for its convenience. The notice of termination shall specify that termination is for the purchaser's convenience in the interest of TPGL.
- 11. APPLICABLE LAW: The contractor/ bidder shall be interpreted in accordance with the laws of the purchaser's country i.e. India. The station of TPGL Headquarter at Agartala shall have exclusive jurisdiction in all matters arising under this contract.
- 12. The Offer shall remain valid for 3 (three) months from the date of opening of the Tender.

- 13. The cost of Tender and EMD may be deposited in the shape of demand draft in favour of Deputy General Manager, Gas Thermal Electrical Division, Baramura, Khowai, Tripura drawn on SBI, TLA House Branch, Agartala.
- 14. The Payment to the agency will be made on quarterly basis at the end of each quarter against submission of invoice in triplicate. Quarter shall mean three months. After completion of each quarter agency must submit a details report of servicing to Engineer –in-charge.
- 15. The bidder shall ensure that in no circumstances the supply of water shall not be stopped in any circumstances other than Holiday (Sunday). In case the bidder fails to supply the water in the working days then a penalty of Rs. 2,500.00 (Rupees Two Thousand Five hundred) only per day will be imposed and will be deducted from the bill.
- 16. The Work Order / Agreement may be cancelled at any time with a notice of 15 days against unsatisfactory performance.
- 17. Carrying / Transportation of Drinking Water by Truck/ Mechanical Transport from DWS sources at Jirania (IR Plant) to Gas Thermal Power Station, Baramura, Khowai Tripura (Location- quarter complex, Division Office, Sub-Division Offices, Plant area etc. as required) including loading, unloading & handling etc. as required considering 1 (one) trip per day and per trip consist of minimum 5,000 litres of drinking water for a period of 12 (Twelve) months (Excluding Sundays) as per direction of Engineer-in-charge.
- 18. Lowest rate quoted by the bidder shall be declared as L1 bidder.

21. The Successful bidder shall have to sign one formal agreement and be required to furnish a contract performance guarantee @ 10 % of the total contract price in the shape of Bank Guarantee / Demand Draft in favour of Deputy General Manager, Gas Thermal Electrical Division, Baramura, Khowai, Tripura drawn on SBI, TLA House Branch, Agartala within 07 (seven) days from the date of issue of LOA. The Earnest Money deposited at the time of dropping of tender may be adjusted with the contract performance guarantee, if agreed by the successful bidder.

22. The successful bidder shall have to sign an agreement on e- Stamp paper of Rs.200.00 (Rupees Two Hundred) only and the said e-stamp paper shall be supplied by the successful bidder.

23. The contract performance guarantee shall be forfeited if the bidder fails to execute the work successfully in scheduled period of completion.

24. The said work may be extended for a period of further 12 (Twelve) months with same rate and term & conditions by mutual consent of both the parties.

25. However, if the bidder and TPGL is not interest to extend the agreement for a period of further 12 (Twelve) months, then the work may be extended upto 15 (fifteen) days from the date of completion of the work with the prior permission of authority.

26. The Price bid will be opened after evaluation of Technical Bid and on fulfilment of all criteria as mentioned in the Tender document for submission of technical bid or qualifying the technical bid.

27. EXTENSION OF TIME

a. TPGL may consider to **grant time extension** for completion of the work if it is felt absolutely essential on fulfilment of following conditions by the Contractor: -

i) The contractor must apply to the Engineer-In-charge in writing for extension of time so required justifying the necessity.

- ii) Such application must state **the grounds** which hindered the contractor in the execution of the work within the time as stipulated in the contract document.
- iii) Such application must be made within 30 days of the date on which such hindrance had arisen.
- iv) The Engineer-in charge must be of the opinion that the grounds shown for the extension of time are reasonable and without extension of such time completion of the work is practically impossible.

b. **The Engineer-In- Charge** will have full powers, but the orders on the application of the Contractor accepted by the Authorities higher than the Engineer-In-Charge shall be issued by him only after written approval from the concerned authority higher than Engineer-In-Charge.

c. The opinion of the **Engineer- in- charge**, whether the grounds shown for the time are or are not reasonable, is final. If the **Engineer- in- charge** is of the opinion that the grounds shown by the supplier / contractor are not reasonable and declines to grant extension to time, the supplier / contractor cannot challenge.

28. ARBITRATION

a. All disputes or differences in respect of which the decision, if any of the Engineer has not become final or biding as aforesaid shall be settled by arbitration in the manner herein after provided.

The arbitration shall be conducted by an arbitrator to be nominated by TPGL and he will be the

sole arbitrator to conduct the arbitration.

The arbitration shall be conducted in accordance with the provisions of Arbitration & Reconciliation Act, 1996 or any statutory modification thereof. The venue of arbitration shall be

d. The arbitrators may, from time to time with the consent of all the parties enlarge the time for

making the award.

The arbitrator shall have full power to review and/or revise any decision, opinion, direction, certification or valuation of the Engineer in accordance with the contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the Engineer for the purpose of obtaining the said decision.

During settlement of disputes and arbitration proceeding both parties shall be obliged to carry

out their respective obligations under the contract.

29. The Tender will receive at the O/o the Deputy General Manager, Gas Thermal Electrical Division, Baramura upto 2:00 Pm on 24/06/2025 fixed for receiving. The bid will be opened on 24/06/2025 at 3:00 Pm, (if possible) in presence of the intending bidder. If the date fixed for opening will be declared holiday or remain closed, the bid will be opened on the next working day with same terms and condition.

30. The bidding documents are not transferable.

31. Any bid received after time and date fixed for submission of bid shall be rejected. Bid received through post/courier after the fixed date and time will not be entertained.

Instructions for Furnishing Bank Guarantee

- 1. Bank Guarantee (BG) for security Deposit cum-Performance Guarantee should be executed on the Non-Judicial Stamp paper of the applicable value and to be purchased in the name of the Bank.


