## Terms and Conditions

1. **Submission of Quotation**
  - Quotation shall be submitted in **two parts (Part-I: Technical Bid and Part-II: Financial Bid)** in sealed covers, super-scribed with NIQ No. and Name of Work.
  - Part-I (Technical Bid) shall contain:
    - Copies of PAN Card.
    - Experience certificate of similar nature of work.
    - Undertaking of acceptance of all terms & conditions.
  - Part-II (Financial Bid) shall contain:
    - Rate in figures and words (inclusive of fuel and driver charges).
    - Applicable GST.
2. **Scope of Work**
  - Provision of one (1) diesel-operated four-wheeler pickup vehicle (Mahindra/TATA or equivalent) along with driver and fuel, for transportation of various materials as and when required under the jurisdiction of Gas Thermal Power Station, Rokhia.
  - The vehicle shall be maintained in good running condition and kept roadworthy at all times during the contract period.
  - The vehicle must possess valid Registration Certificate, Insurance, and Road Permit throughout the contract duration.
  - The vehicle shall report to the designated Officer-in-Charge as per instructions issued from time to time.
3. **Period of Contract**
  - The contract shall remain valid for **10 months** or till completion of requirement, whichever is later.
4. **Payment Terms**
  - Payment shall be made on a **quarterly basis** against submission of bills in triplicate duly certified by the Officer-in-Charge.
  - Statutory deductions such as IT, GST-TDS etc. will be made as per applicable rules.
5. **Rates**
  - The quoted rates shall remain firm and final during the entire contract period.
  - Rates shall be inclusive of driver charges, fuel, lubricants, maintenance, and all applicable taxes & duties.
6. **Penalty / Liquidated Damage**
  - In case of failure to provide vehicle as per requirement or unsatisfactory performance, penalty @ **Rs. 500/- per day** or part thereof shall be imposed, subject to a maximum of 10% of contract value.
  - Repeated failure may lead to termination of the contract.
7. **Termination of Contract**
  - TPGL reserves the right to terminate the contract at any time with 15 days' prior notice without assigning any reason.
8. **Responsibility of Contractor**
  - The contractor shall be fully responsible for compliance with all labour laws, insurance, road permits, pollution clearance, commercial driving licence and other statutory obligations.
  - Any accident, injury or damage caused during operation of the vehicle shall be the sole responsibility of the contractor.
9. **Consignee**
  - The Sr. Manager, Gas Thermal Mechanical Sub-Division No.-I, Rokhia Sepahijala, Tripura.
10. **Validity of Offer**
  - The quotation shall remain valid for **90 (ninety) days** from the date of opening.
11. **Right to Reject**
  - TPGL reserves the right to accept or reject any or all quotations without assigning any reason thereof.

**12. Submission & Opening**

- Quotations must be submitted at the O/o the Addl. General Manager, Generation Circle, Bidyut Bhavan, Agartala or O/o the Deputy General Manager, GTED, Rokhia, by **24/09/2025 up to 5:00 PM.**
- Quotations will be opened on **25/09/2025 at 3:00 PM** in the O/o the Deputy General Manager, GTED, Rokhia, if possible, in presence of intending bidders.
- If the date happens to be a holiday, the quotations will be opened on the next working day.

**13. Late Submission**

- Quotations received after due date/time, including through post/courier, will not be entertained.

**14. Bid Signing**

- All pages of the bid must be signed by the bidder. Corrections must be initialled.

**15. Disputes**

- In case of dispute, the decision of TPGL authority shall be final and binding.

**16. ARBITRATION**

- All disputes or differences in respect of which the decision, if any, of the Engineer has not become final or binding as aforesaid shall be settled by arbitration in the manner hereinafter provided.
- The arbitration shall be conducted by an arbitrator; to be nominated by TPGL and he will be the sole arbitrator to conduct the arbitration.
- The arbitration shall be conducted in accordance with the provisions of Arbitration & Reconciliation Act, 1996 or any statutory modification thereof. The venue of arbitration shall be at Agartala.
- The arbitrators may, from time to time with the consent of all the parties enlarge the time for making the award.
- The arbitrator shall have full powers to review and /or revise any, decision, opinion, direction, certification or valuation of the engineer in accordance with the Contract and neither party shall be limited in the proceedings before such arbitrators to the condense or arguments out before the engineer for the purpose of obtaining the said decision.
- During settlement of disputes and arbitration proceedings, both parties shall be obliged to carry out their respective obligations under the contract.
