## Addendum

In continuation to the earlier Memorandum vide No.F.AGM (DP&C)/TSECL/TF-EMD/19-20/2038 dt. 11<sup>th</sup> Dec'2022 regarding Policy for adoption of Vendor approval, it is incorporated that one Engineer of TSECL will visit the factory site to witness Production Unit and check the quality of material also verify the upto date Calibration Certificate of each inspection equipments. The inspecting Engineer of TSECL will submit the detail report which will be checked by the concerned office and accordingly Vendor approval will be issued. The details are described below.

- 1. Before any Vendor approval, TSECL's 1(one) Technical Official will visit factory site of the Firm/Manufacturer who has applied for Vendor approval to witness the infrastructure and quality of product etc. as required with checking of valid calibration certificate.
- 2. Expenditure for to and fro journey by Air from Agartala to nearest Airport of factory site to be borne by or arranged by the Firm.
- 3. Expenditure for local convience from Airport and around the factory premises for inspection and back to Airport after completion of inspection to be borne by the Firm.
- 4. Expenditure for to and fro journey by road from Agartala City to Agartala Airport and back to be borne by the Firm.
- 5. Expenditure for loadging, fooding and transport arrangement during inspection period to be borne or arranged by the Firm.
- 6. Date of inspection to be fixed by TSECL.
- 7. The validity of vendor approval will be continued upto next 3(three) years from the date of issue. The same will be treated for those who were issued letter earlier.
