Terms & Conditions of Tripura State Electricity Corporation Limited (TSECL) for Appointment of 'Management Trainee' against the post of 'Manager (Electrical), Grade- B'

1. The appointment of 'Management Trainee' against the post of Manager (Electrical), Grade-B under Tripura State Electricity Corporation Limited (TSECL) is purely on temporary basis.
2. Initially **Management Trainees will be appointed** in their respective functional stream viz Electrical at a consolidated remuneration @ **Rs.12,500/-** per month and on successful and satisfactory completion of the training period, they will be absorbed as **Manager (Electrical), Grade- B under TSECL and then their pay will fix up at Level-10** in the pay matrix as per Tripura State Civil Services (TSCS) Rules (revised pay), 2018 w.r.t pay band scale **Rs. 5700-24000/- (PB-2)** plus allowances; subject to revision by the Government time to time.
3. If a 'Management Trainee (Electrical)' fails in successful completion of training period, his /her training period may be extended maximum upto 2 (Two) years for improvement and successful completion of the training period. The nature of training shall be broadly on the job training i.e, learning by doing at their place of posting and/or any other method as arranged by the Corporation time to time. The remuneration during the extended training period will be similar to the training period.
4. On successful completion of training period every Manager (Electrical), Grade-B has to serve TSECL for a period of minimum 5 (Five) years. In this regard a specific declaration has to be given by the Appointees at the time of their joining in TSECL, which will be treated as the signing of Bond by the Appointees. However, if any appointee desires to leave the corporation during the training period or 5 (Five) year bond period, he/she has to refund the entire training cost [i.e, **Rs. 12,500 or Salary amount x no. of months of training/ Service period, he/she attended in TSECL**] with **simple interest @ 10%**.
5. The appointment may be terminated at any time by either side, namely the appointee or the appointing authority without assigning any reason thereof but by giving 1(one) month notice or before the expiry of the stipulated period of Notice by making payment of a sum equivalent to the pay for the period of Notice of the unexpired portion thereof in addition to the refund of training cost as mentioned above, if applicable.
6. The appointment carries with the liability to serve in any part of the State of Tripura / at any place falling in the operational area of TSECL.
7. It has to be stated whether the candidate is serving; or is under obligation to serve, the Central Government, any other state Government or a public authority.
8. No. TA / DA will be allowed for joining the appointment issued / offered to him / her.
9. No Pension from Govt. of Tripura or TSECL. However will be entitled for benefits of EPF, if so desired.
10. **The appointment will be further subject to :**
 - i. Production of Medical Fitness Certificate from Civil Surgeon/ S.D.M.O/ Superintendent/ Deputy Superintendent/ Government Female Medical Officer (for female candidates) of any Hospital of Government of Tripura [as per prescribed Format].
 - ii. In case of Physically Handicapped persons, such medical fitness certificate should be obtained from the Chairman, Special Medical Board constituted by the Government of Tripura.
 - iii. Taking of an oath of allegiance to the Constitution of India in the prescribed format.

- iv. Submission of declaration in the prescribed format and in event of the candidate having more than one spouse living, the appointment will be subject to his / her being exempted from the operation of restriction in the recruitment in this behalf.
 - v. Release order of competent authority if candidate in service.
 - vi. Submission of duty filled Attestation Form in (2 copies).
11. **Candidates are required to submit 2 (two) copies each of the following certificates (attested photocopies):**
- i. Degree/Diploma Certificate(s) & Mark-sheet(s) of Educational qualification (Matriculation onwards).
 - ii. Age proof certificate.
 - iii. Certificate in the prescribed form in support of candidate belonging to a Schedule Castes (SC) or Scheduled Tribes (ST) Community or Physically Handicapped (PH) category or Ex-servicemen category.
 - iv. Discharge certificate of previous Company, if any.
 - v. Certificate of Character from 2 Officers in the **enclosed** form. Here, an Officer means any of the following.
 - a) Gazetted Officers of Central or State Government;
 - b) Members of Parliament of State Legislature belonging to the Constituency where the candidate or his parent/ guardian is ordinarily resident,
 - c) Sub-Divisional Magistrates/ Officers.
 - d) Tehsildars or Naib/ Dy. Tehsildars authorized to exercise Magisterial Powers.
 - e) Principal/ Headmaster of the recognized School/College/ Institution where the candidate studied last.
 - f) Block Development Officer
 - g) Postmaster; and
 - h) Panchayat Inspectors.
 - vi. Citizenship Certificate and Valid PRC or PRTC, Aadhar Card, Voter ID.
 - vii. Ration Card (both side of the front page).
12. The original Employment Registration Card should be submitted.
13. If any declaration given or information furnished by the candidate is proved to be false or if the candidate is found to have willfully suppressed any material information, he / she will be liable to removal from service and such other action as the Corporation may deem fit.
14. **Job Description of Manager (Electrical), Grade-B** in TSECL are as below:-
- i. Planning, Operation & maintenance of Distribution, Transmission & Generation systems of TSECL including Tariff, Commercial & System Operations, Trading etc. related jobs
 - ii. Beside above any other activity in the interest of TSECL as and when required.
15. Other service conditions will be applicable to Tripura State Civil Service Officers of equivalent grade till the formation of service rules of TSECL. On formation of service rules of TSECL, he/she will be guided by the same.
